# Minutes of the Annual General Meeting held on 12 November 2024 at Cloverdale Retreat Café, Priory Park, Bedford

- 2 Minutes of meeting held on 7 November 2023 and matters arising The minutes were agreed as an accurate record. There were no matters arising.
- 3 Chairman's Report on the work of the Friends of Putnoe Wood and Mowsbury Hillfort for the year 2023/24

Dave presented the Chairman's report as follows.

I would firstly like to that you all for your hard work over the last year. I believe that we have maintained both sites in a manner which continues to make them both accessible and enjoyable. Certainly, with one exception, all the visitor feedback I have received has been very positive. The reports from visits undertaken by Green Flag and other inspectors have also provided positive feedback.

Lynn summarised the main tasks as listed below.

### Mowsbury Hillfort

Nov 23 Dec 23	Branches removed from dead pine. One pine and 2 cypresses lopped. Part of ash tree sheared of into south moat. Partly chain sawed and

June 24	Jon Bishop conducted a visit from Aylesbury Vale volunteers to both sites.

July 24	Green Flag awarded following a site visit.								
Aug 24	Entrance gate post re-set.

The Vision was reviewed and re-issued with a plan showing all the site designations. The planning application for 3 bungalows on a site adjoining the hillfort site went to appeal and was dismissed on 27 Sept 24.

Jon Bishop met with Historic England on site. No written feedback was received, but positive comments were made on site.

# Putnoe Wood

Coppicing of plot 1g was completed early in 2024. Plot 1h is currently being worked on including being brush-cut.
19 June 24 Visit from Castle Newnham School.
Small balsam was brush-cut and pulled.
Green flag was awarded following a mystery shopper visit.

### General

The new benches at the Hillfort and Putnoe Wood using the donation from Airedale Nursing Home are still to be installed.

# 4 Report of the accounts of the Friends of Putnoe Wood and Mowsbury Hillfort for the year. (submitted in Peter Stathers' absence)

Our bank balance at the time of this report stands at £586.72 with a petty cash fund of  $\pounds 22.08$ , which at first glance is at a similar level to what it was at the end of the previous year. Again  $\pounds 250$  of this is a donation for seating to be located in the Hillfort/woods areas, and therefore our actual bank available fund is only £358.80 (total).

A Wassail took place in January this year, which once again enabled us to make a £150 donation to the local Foodbank. The plan is to support the Foodbank again in 2025. Also, as we have continued to bring our own refreshments, a proposal was made to request voluntary donations of £12 pa to help to fund the web site and other ad-hoc expenses. This will be formally proposed at AGM.

Our only other item of expenditure this year was for the Web Site which was significantly higher than the previous year. So our 'kitty' is likely to continue with a buffer to cope with any unexpected payments.
